Treasurer's Report:

Cash on Hand, as of 10-31-2020: \$18,106.45.

Outstanding dues owed to State PTSA: \$217.50

Audit

'19-20 completed virtually by Sept 30, 2020 by a committee of three. There were some issues noted. *Audit report adopted, by a vote of 16-0.* The audit report will be added to the minutes.

Amendments:

Dues change: Article 5, section 7. Strike out "6" and replace it with "7." This changes the yearly dues from \$6 to \$7. *Motion to approve change passes 16-0.*

Election date: Article 6, section 3 and 8c: Strike out "March" and replace it with "April." This changes PTSA elections from March to April, to be in line with other local units. *Motion to approve passes 16-0.*

Fall Fundraiser:

Exceeded expectations, sold 180 items. Raised \$1200 for technology. Thanks to everyone who helped, shared and bought.

Will have an opportunity for pick up on Friday, November 20 at the Park across from SAA.
